

THE DISNEY VACATION CLUB INSTANT WIN GAME
OFFICIAL RULES

NO PURCHASE NECESSARY TO ENTER, WIN OR CLAIM A PRIZE. A PURCHASE OR PAYMENT WILL NOT INCREASE AN ENTRANT’S CHANCES OF WINNING.

1. **PROMOTION PERIOD:** The Promotion begins on December 29, 2021 at 12:00 PM (noon) Eastern Time (“ET”) and ends on June 30, 2022 at 11:59:59 PM ET (“Promotion Period”) and includes twenty-six (26) entry periods (each an “Entry Period” as outlined in the chart below:

The Administrator's computer is the Promotion's official clock.

2. **ELIGIBILITY:** This Promotion is offered only to legal residents of the fifty (50) United States and the District of Columbia who are at least eighteen (18) years old or the age of majority in your state of jurisdiction (whichever is older) at the time of entry. Officers, directors and employees of Sponsor, Administrator, and any of their respective owners, parent companies, affiliates, directors, subsidiaries, franchisees, representatives, advertising, promotion and production agencies, agents (all such individuals and entities collectively referred to herein as the "Promotion Entities") and their immediate family members (*i.e.*, spouse, parent, child, sibling, and the "steps" of each) and persons living in the same household of each are not eligible to participate in the Promotion. Void where prohibited or restricted by law. All federal, state and local laws apply.

Participation constitutes entrant's full and unconditional agreement to these Official Rules and Sponsor and Administrator's decisions, which are final and binding in all matters related to the Promotion. Winning a prize is contingent upon fulfilling all requirements set forth herein. Entrants and/or potential winners may be required to provide proof of identification and eligibility as required by Sponsor or Administrator.

For purposes of the Promotion, an entrant's residential address and e-mail address will be the physical address and e-mail address submitted at the time of entry. Entrants will not be allowed to change their physical address or e-mail address. If it is discovered or suspected that an entrant has registered or attempted to register for the Promotion using multiple e-mail addresses or multiple identities, all of that entrant's Game Plays (as defined below) associated with that household (determined by Sponsor and/or Administrator in its sole discretion) may be disqualified and any prize an entrant might have been entitled to win will not be awarded and may be revoked. Use of any automated system or any like methods to participate in the Promotion is prohibited and will result in disqualification of any entrant attempting such use.

3. **HOW TO PARTICIPATE:** There are two (2) ways to access the Promotion website ("Website") to participate in the Promotion:
 - A. **In-Person Engagement:** During the Promotion Period, an eligible entrant may visit a kiosk, open house, or other DVC activation location at Walt Disney World Resort, Disneyland Resort, or AULANI Resort, and find a DVC Cast Member. Entrant may scan QR code on DVC Cast Member's tablet or access the provided URL on their personal device to access the Website.
 - B. **Visit Website Directly:** During the Promotion Period, an eligible entrant may visit the Website at DVCInstantWin.com. **NOTE:** During the Promotion Period, an entrant may receive a link to the Website by scanning the QR code on select Promotion print advertising. An entrant may center the QR code in the camera and scan the QR code. Once completed, the entrant will receive a link to the Website. **An entrant cannot participate solely by scanning the QR code.**

Regardless of method of accessing the Website, once on the Website, an eligible entrant must select whether or not they are a *Disney Vacation Club* Member. **Note that being a *Disney Vacation Club* Member or becoming a Member of *Disney Vacation Club* is not required to**

enter this Promotion, nor will it improve your chances of winning. Entrant must then follow the on-screen directions to register by providing the information requested by Sponsor including, but not limited to: email address, complete first and last name, street address (P.O. Boxes are not permitted), city, state, ZIP code, phone number, phone type and confirmation entrant has read and agrees to be bound by these Official Rules to receive one (1) game play (“Game Play”). The entrant will then be presented with a door to open that will animate and reveal whether the individual is a winner or not. After a valid Game Play, the entrant will receive an on-screen notification indicating whether he/she is a potential Instant Win Game prize winner (“Notification”). Each entrant who receives a winning Notification will be deemed a potential Instant Win Game prize winner subject to verification of the entrant’s eligibility and compliance with these Official Rules, as determined by Sponsor in its sole discretion. There is a limit of one (1) prize per person during the Promotion Period. Once a prize has been awarded, any remaining unused Game Plays will be automatically forfeit.** If an entrant wishes to view or complete the video at a later time, they will be able to revisit the Website at any time during the Promotion Period and enter their email address to revisit the video at the point at which they previously abandoned. **Limit:** An entrant may watch the Video one (1) time during the Promotion Period and earn five (5) bonus Game Plays. - B. Total ARV:** The total ARV of all available prizes in the Promotion is \$52,000. The total Arv of all Prizes in each Entry Period is \$2,000.
